SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Exclude sources of ignition and be aware of explosion hazard. Ventilate the area. Avoid breathing vapor or mist. Refer to protective measures listed in sections 7 and 8. 7.1 Precautions for safe handling

Vapors are heavier than air and may spread along floors. Vapors may form explosive mixtures with air. SECTION 8: Exposure controls/personal protection

Appropriate engineering controls

SECTION 11: Toxicological information

11.1 Information on toxicological effects
